Dear Mr. Castanon:

This responds to your letter of May 23, 2019, in which you provide a reconfirmation of the Army Corps of Engineers' (Corps) May 26, 2017, conclusion that the proposed action at the Villages at Vigneto Development offsite mitigation parcel may affect, but is not likely to adversely affect western yellow-billed cuckoo (*Coccyzus americanus*) and, in conference, its proposed critical habitat; the southwestern willow flycatcher (*Empidonax traillii extimus*); and the northern Mexican gartersnake (*Thamnophis eques megalops*) and, in conference its proposed critical habitat. You also asked whether the U.S. Fish and Wildlife Service (Service) has changed its October 26, 2017, concurrence with the Corps' effects determination in light of recent allegations of political interference made by former Service employee Steve Spangle.

The Arizona Ecological Services Office has reviewed our October 26, 2017, correspondence and the records leading to our concurrence, including the Corps' and El Dorado Holdings, Inc.'s confirmation that development of Villages at Vigneto is feasible with or without a Clean Water Act 404 Permit. We continue to defer to the Corps' determination regarding the "no Federal action alternative" for the Villages at Vigneto Development and concur with the Corps' effects determination limited to the activities at the mitigation parcel.

We take the allegations made by Mr. Spangle seriously. For this reason, our reevaluation has occurred at the field office level only with no regional or Washington D.C. headquarters review. Mr. Spangle's allegations do not change our previous determinations regarding the effects of the Corps' actions on listed species or their designated or proposed critical habitat in the action area. Our decision is based only upon facts contained in the records supporting our October 26, 2017 concurrence.

In the event that typical section 7 reinitiation triggers are met, there is a change in Corps' or El Dorado Holdings' intent, or a redirection from the Court in the ongoing litigation on the project, we will be available to assist with further consultation pursuant to the Endangered Species Act's implementing regulations at 50 CFR § 402.
